




• Mapping LISK 7 Police Jurisdictions







Alex Diaz contacts Pak. Trying to locate Shannan. Calling hospitals and police stations. Eventually Pak connects them to Joe Brewer. Alex arrives at Oak Beach and meets Brewer. Brewer takes him to police station where they try to file a police report. Alex returns to Oak Beach, is stopped at the gates and told to wait. Hackett comes out to meet him. Speaks at length with Hackett who makes notes and offers to help.

Hackett calls Mari (proven by her phone records) and speaks to her for 5 minutes. Hackett initially denies making any call, but would later admit to it. • Summa contra Dr. Hackett Timeline May 5<sup>th</sup> and 6<sup>th</sup> 2010

Alex and Michael return to Oak Beach. Hackett offers again to help get the police involved in the search.

Hackett claims Alex gave him Mari's number and asked to call it. After denying for a year that a call happened he later claimed to Mari that she called him first and he just called her back.

He claims he spoke to her twice on this day, no call lasting for more than 3 minutes.






### Victims Put Up Long Fight, A Witness for Simpson Says



- Intelligent, independent
- Middle class or above
- Access to a vehicle and to a domestic area where he can keep victims
- Seasonal work
- White
- Age today 40 50

- Profiling LISK
- Ritualistic behaviour
- Total control of the victims, even in death, stripping them of their identity
- Showing his contempt of the victims by tossing them out like rubbish
- No burial, no effort to hide victims
- Enjoys causing anguish and suffering
- Increases the families' suffering with phone calls
- Enough self control to lie dormant for longer periods
- Relives his crimes through following media coverage
